- If any election is contested the poll will take place on Thursday, 7th May 2015.
- Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at West Berkshire Council, Council Offices, Market Street, Newbury, RG14 5LD by 5 pm on Tuesday, 21st April 2015.
- Applications to vote by proxy at this election must reach the Electoral Registration Officer at West Berkshire Council, Council Offices, Market Street, Newbury, RG14 5LD by 5 pm on Tuesday, 28th April 2015.
- Applications to vote by proxy at this election applied for on grounds of physical incapacity, or for work/service reasons where that physical incapacity, or work/service reason occurred after 5 pm on Tuesday, 28th April 2015, must reach the Electoral Registration Officer at West Berkshire Council, Council Offices, Market Street, Newbury, RG14 5LD by 5 pm on Thursday, 7th May 2015.
