18/44 **To review any updates and progress of the Planning Application for MOR006. 17/03004/OUTMAJ:**

Pro Vision have advised that amended plans for a short consultation were being submitted with West Berkshire Council and these were provided to the SMPC office for review.

A major change was the amendment to now 'pepper pot'/disperse the affordable housing units across the site rather than put them all in one area. There were also changes to increase the landscaping on the eastern boundary and the removal of the LAPs and the incorporation of a 'play trail' in the large area of public open space on the southern side of the site.

A report on drainage and flooding has been carried out by a consultant with West Berkshire Council which considered national standards but has not taken on board SMPC NDP Policy GD3 standards. It was agreed that SMPC would write to the Planning Officer to formally raise this issue with West Berkshire Council.
