<b>19/020</b>	<p><b>Fairground and Grazing Area Access:</b></p> <p><b>1. To review all current means of access to the area.</b></p> <p>All means of access to both the front and grazing areas of The Fairground were reviewed, and potential issues raised and discussed.</p> <p><b>2. To AGREE actions to be taken to reduce unauthorised access.</b></p> <p>A plan was established to increase the security of The Fairground. This included temporary measures to take place with immediate effect, whilst longer term solutions are investigated and deployed. Consideration was given to the need for ongoing access versus the need for security. Advice regarding emergency access requirements shall be sought accordingly.</p>
