Several complaints have been received regarding the state of the overgrown hedges along the footpath. The one off cost of cutting back the hedges, whilst the overall responsibility for the maintenance of the footpath is established, is £320.00.</p> <p>Proposed by Cllr. Lewis, it was unanimously RESOLVED to place the order for cutting back the hedges from Stephens Close.</p> | Clerk |

The suitability of the Westcotec ANPR/SID for Community Speedwatch purposes is being reviewed at the Community Speedwatch Strategic board meeting in October. Cllr. Kilshaw reported that the Westcotec units are being used for Community Speedwatch purposes in Durham and at Heathrow Airport.</p> | |

Lewis and the Clerk to establish the potential changes needed, which accurately reflect the status of the commons and SMPC run land. Cllr.
