	It was noted:	
	<ul> <li>The quote from Wicksteed includes 8 pieces of fitness equipment.</li> <li>Other possible ideas for a Members Bid i.e. a drinking fountain or grey water collection, would not currently be possible due to the</li> </ul>	
	poor water pressure on the Fairground.	SH LJ

19/07	To receive an update on the Fairground and play equipment:	

	The ROSPA annual inspection has been undertaken. Quotes are being obtained for the work required and two orders have already been placed for repairs needed deemed as high risk. quotes are being obtained.  Some tree work, not authorised by SMPC, has recently been done on the road side of Hammonds Heath. This is likely to be managing branches with regards to cables.  It was AGREED:  The Committee would meet on site late August and then every 3 months to monitor and review work required.  To look to review Mr. N. 	Fairground Ponds	
	<ul> <li>Most of the required work for Phase 1 has now been undertaken. Phase 2 will be undertaken in the Autumn.</li> <li>As per the ground's maintenance specification, the newt corridor remains uncut apart form the area around the small pond.</li> <li>Consideration will be given to the ecology report, suggesting the planting of a hedge by the repaired fence which will give cover for the newts</li> </ul>	JB
	Conservation Area and Footpaths	
	<ul> <li>Various options for repairing the footpaths were discussed. It was noted that, as the footpath is a public footpath, the specification needs to be agreed by West Berkshire Council (WBC).</li> </ul>	Clerk
	As a temporary measure, it was proposed by Cllr, S. Hill, seconded by Cllr, D. Morsley, that gravel will be applied to the area. This was <b>AGREED</b> by 3 votes to 2.	SH

	<ul> <li>Due to size, it may be necessary for the lime trees to be removed. A decision will be taken once the tree survey has been undertaken.</li> <li>A quote has been sought for cutting the hedge back by 1/3.</li> <li>WBC have been asked to confirm if new planning permission is required as the design of the bridge for the cemetery extension has changed.</li> <li>Sarum Hardwood Structures Ltd will be asked to confirm the lead time and any price change for the new bridge.</li> </ul>	Clerk
