#### a. Mortimer Station Car Park Planning Application

Further to the Eastern Area Planning Committee (EAPC) meeting held in August, ProVision has submitted all the additional required documentation to the case officer. The case officer was still waiting for the parking technical note and comments from Highways and the application has therefore been deferred to the EAPC meeting on the 28<sup>th</sup> October. Although the decision will be made on the 28<sup>th</sup> October, an extension to the 30<sup>th</sup> October has been agreed with the case officer. This will enable the case officer time to process and issue the decision notice. A letter has been received from the agent representing the owners of the Calor Gas site, confirming the withdrawal of their opposition, and actively supporting the application. This has been forwarded to the case officer.

# 20/02244/OOD: Out of District Planning Consultation, Hampshire County Council, Mortimer Quarry, Welshmans Road, Mortimer West End, RG7 3UQ

Variation of condition 3 to permission BDB/73759 for the revision of the end date to 31 October 2032.

**SMPC comments:** It was a condition of the project that gravel lorries do not travel through Mortimer. It has been noted, however, that recently several lorries a day are now driving through the village and confirmation that the condition still applies is sought.

#### 20/01905/COND4: Land south of St Johns Church of England School

Application for approval of details reserved by conditions (21) Cycle storage, (25) Elec charging points, (27) Lighting and (30) Broadband of planning permission 19/00981/OUTMAJ - Section 73: Variation of condition 6-approved plans of approved application 17/03004/OUTMAJ.

**SMPC comments:** Confirmation is sought regarding the number of electric vehicle charging points marked in red on the plan (i.e. to be connected in the future) being fitted and if there are sufficient units to allow reasonable access for all flats and dwellings.

**SMPC Additional Comment:** 20/01984/COND1 and 20/01905/COND4 were not sent to SMPC but located on the Planning Portal. SMPC are consultees for all conditions and documents regarding MOR006 and these should be sent by West Berkshire Council to SMPC accordingly.
