Minutes and Matters Arising: 03/80 Minutes:

The Minutes of the Meeting of 10th April 2003 were approved as a true record and signed by the Chairman.

Code of Conduct, Register of Members' Interests, Declaration of Acceptance of Office and 03/81 Change of Bank Signatories: Councillors were given copies of the Code of Conduct, Register of Members' Interest, and Declaration of Acceptance of Office forms to complete and return to the Clerk. The Change of Bank Signatories was held over until the next meeting.

03/82 **Resolutions to be Considered by the Council (Previously Circulated):** Cllr A Thorpe proposed that the Resolution "That with immediate effect it be the rule that all formal documents of the Council be signed by not less than three Councillors" be accepted. This was seconded by Cllr C Lewis and unanimously agreed. Carried. The other Resolution circulated authorising the Clerk a monthly budget was passed to the Financial & General Purposes Committee.

03/83 **Report from District Councillors:**

Councillor Lock reported that the yellow lines were about to be done and that he was still trying to have the graffiti removed from the signs. He advised that he had been elected Chairman of West Berkshire Council for the year 2003-04.

- 03/84 **Planning:** Cllr Morden reported that the Planning Committee had met once since the last Council Meeting on Wednesday 16th April 2003 to consider four applications:

The Following Planning Decisions have been received from West Berkshire Council:

- 03/001116FUL 54 Victoria Road (Victoria Arms) a detached annex to provide family accommodation. The existing derelict buildings to be demolished. Approval subject to Section 106 Agreement (i.e. a legal agreement tying the use of the annex to the public house in line with the Parish Council's comments. 03/00328/FUL 53 Aborn Parade. Change of use to A3 (take away food). Recommendation Refusal. (we understand this application has now been withdrawn) 10 Spring Land. Extensions to side and rear. Notwithstanding Parish Council's objection and 02/00236/HOUSE two other letters of objection the recommendation is for Approval. 03/00140/HOUSE 9 Mortimer Lane. Retrospective application for installation of sun pipes and erection of boundary wall. Mortimer Parish Council and Wokefield Parish Council objected. Highways recommended refusal all in respect of the wall adjacent to the road. The applicant has been invited to submit a separate application for the sun pipes (water convection heaters) but the Wall is recommended for Refusal. 03/00566/HOUAE Eastrop, The Street. Single storey side extension. Recommendation approval. 03/00629/HOUSE 64 The Avenue. Rear extension to provide new dining room. Recommendation approval. 03/00532/FUL Aborn Parade, West End Road. Proposed flat and maisonette. Recommendation refusal. i. Suggestion of Name for Development at Mortimer Garage, West End Road: After some discussion Cllr G Puddephatt proposed that the above development be named "Crichton Court" after the Crichton family and all they have contributed to the village. Cllr J Morden seconded this and was unanimously agreed. Cllr Morden is to confirm with Dr Crichton that he has no objection to this.
- 03/85 **Roads, Footpaths and Commons:** Cllr Puddephatt read out a letter from West Berkshire Council about a letter they had received from Dr Collins re the renaming of Reading Road/Burghfield Road and Five Oaken. It appears that the stretch of road initially called Burghfield Road has now been renamed Reading Road and Dr Collins has asked that it be rectified. It was unanimously agreed that The Clerk should inform West Berkshire Council that they recommend that the stretch of road concerned revert back to Burghfield Road.
 - i. **Update on Vehicle Access Across Brewery Common:** Cllr Davies said that a letter had been received from the residents of Brewery Common asking if an easement could be granted outside the Act with the only charge being the legal fees. He read out a proposed reply saying that the Council's policy is to comply with the relevant legislation and is to await clarification from West Berkshire Council of the meaning (or legality) of granting an easement "outside the Act". It was agreed the letter should be sent. Cllr Davies has asked the Legal Department at West Berkshire Council for any information they may have on this.
 - ii. **Transportation of Freight in West Berkshire (Through Mortimer) Survey:** This was passed to the Roads, Footpaths and Commons Committee to comment on.
 - iii. **Letter re "Improvements" to Car Park St John's Church:** Cllr Puddephatt read out a letter received regarding the upgraded car park outside St John's Church saying that the larger car park is encouraging cars to cut through. The letter also commented on the fact that the pavement was not widened, as a result is difficult for parents with pushchairs now

that the cars overhang the pavement. Cllr Lock has already replied to the letter and **Cllr Harding** is to look at the safety aspects of the car park. **The Clerk** to send a suitable reply on behalf of the Parish Council.

- iv. **Request from Mortimer Scouts to use Car Park West End Road for a Car Wash:** A letter has been received from the 1st Mortimer Scout Group asking if they could use part of the car park in West End Road for a fund raising car wash. This was unanimously agreed. **The Clerk** to reply.
- V. **Fly Tipping and Abandoned Vehicles in West Berkshire:** The Clerk advised that West Berkshire has produced a booklet advising on the procedures to deal with fly tipping and abandoned vehicles in West Berkshire. This will be kept in the Parish Office.

03/86 **Fairground, Trees and Amenities:**

i. **Mortimer Fairground Trust Report**: Cllr Davies asked if the decision taken at last month's meeting to chase the Charity Commission for a response to our letter be reversed so it was agreed not to write to the Charity Commission but await any further communication from them.

03/87 **Cemetery:** No Report

- 03/88 **Annual Return and Basic Audit from Hacker Young:** The Clerk advised that the Council have been called to Audit and that the accounts for the year ended 31st March 2003 will be presented to the Council for approval at the June Meeting.
- 03/89 **Legacy to Parish Council from the Late S D Beards £1,000:** This item was held over from last month's meeting and Cllr Thorpe proposed that a bench (with commemorative plaque) be purchased with the legacy and sited near the cricket pavilion on The Fairground as the late Mr Beards enjoyed playing cricket at Mortimer. The estimated cost for the seat would be approximately £600. Cllr Philips seconded and was unanimously carried. Any remaining monies to be passed to the Fairground, Trees and Amenities Committee who were asked to come up with suggestions on how to spend the remaining money on the Fairground (possibly the Children's Play Area). **The Clerk** to action purchase of seat.
- 03/90 **To Consider Sending Delegate(s) to the NALC Conference, Cardiff, 3 5 October 2003 at a delegate cost of £110 plus VAT and Accommodation Costs.** Councillors Puddephatt and Jones showed an interest in attending the conference and it was decided to hold this over until the next meeting for other councillors to consider.
- 03/91 **To Consider Subscribing to Direct Information Service Newsletter £87.00 per year:** Cllr Davies proposed that the Council subscribe to this useful informative fortnightly publication, Cllr Jones seconded this and it was carried unanimously.
- 03/92 **To Consider Purchasing Governance & Accountability in Local Councils A (New) Practitioners' Guide At A Cost of £16.99:** Cllr Davies proposed that we purchase a copy of the above Practitioners' Guide to assist the RFO in completing the Council's Accounts. Cllr Thorpe seconded this and it was carried unanimously.
- 03/93 **To Consider Clerk Attending LCAS Health & Safety Seminar on 3rd June 2003 at a Cost of £30.00 plus VAT:** Cllr Morden proposed that The Clerk attend the above Health and Safety Seminar on the 3rd June. Cllr Davies seconded this and it was carried unanimously.
