

# Stratfield Mortimer Parish Council Minutes of the Parish Council Meeting held on 12<sup>th</sup> January 2012 @ 7.30 p.m.

- 12/01 **To approve Minutes of Parish Council Meeting 08.12.2011:** The Minutes of the Parish Council Meeting of 8th December 2011 were approved as a true record and signed by the Chairman.
- 12/02 **To be advised of the appointment of a new Parish Custodian:** The Chairman advised that a new Custodian had been appointed, his name is Mark Bradberry and he will be starting on the 13.01.2012.

# 12/03 To receive Clerk's update (for information only):

11/158: The work to replace the diseased horse chestnut trees with new lime trees is to commence on the week commencing the 16.01.2012.

11/241: The installation of replacement safety surfacing in the play area is to be carried out on the week commending the 16.01.2012.

11/213: The work to replace the 'dragons teeth' (wooden posts) around the pond at the war memorial junction is being carried out this week.

11/226: Overhanging hedge, The Street: Both the Clerk and Cllr Lock have been in touch with West Berkshire Council (WBC) who have agreed to follow this up.

11/185: Damaged equipment on Adventure Area: Kompan Ltd has agreed that the damaged chime bars can be replaced with an equivalent Kompan alternative.

11/211: Planning Application for a Certificate of Lawfulness for a storage shed on the Fairground: An email from WBC Planning Department regarding the proposed usage of the shed was read out.

11/187: Christmas Tree hole on the Fairground: The Clerk confirmed that in order to accommodate next year's Christmas Tree arrangements have been put in hand to permanently seal the hole with a manhole and removable cover at an approximate cost of  $\pounds 200$ .

- 11/02468/AGRIC Little Park Farm. Proposed Barn. Full planning not required (General Permitted Development) Order 1995.
- 11/02222/CERTP The Aviary, The Street. Demolition of existing garage and erection of oak frame building on existing site. Withdrawn.

<u>Appeal Decision:</u> 10/02921/FULD 42 West End Road. New 3 bedroom house. The appeal is dismissed. Cramped development and uncomfortable relationship with immediate neighbour.

12/06 **To receive information from the Communications Committee regarding the arrangements for the public meeting re funding Superfast Broadband and update on the next edition of the Parish Council Newsletter:** The Clerk advised that the Communications Committee met on the 09.01.2012. The content and timetable for the next edition of the Parish Council Newsletter was discussed and agreed. This edition of the Newsletter is to be distributed during the weekend of the

11/12.02.2012. The arrangements for the public meeting to be held on the Saturday 25.02.2011 at 10am in the Methodist Church Hall were discussed and agreed. WBC's Head of ICT is to attend. The public meeting is to be advertised in the Newsletter.

- 12/07 **To receive update from the SMPC Queen's Jubilee Beacon Working Party:** Cllr Earl reported that there was no update. The next meeting is to be held on 06.02.2012.
- 12/08 **To receive update from the Parish Plan Surgery 22.11.2011:** No written report has yet been received from WBC. Clerk to chase.
- 12/09 **To consider providing the provision of allotments in the field adjacent to Church Lane:** No further update.
- 12/10 **To consider way forward for SMPC re new National Planning Legislation:** It was agreed that this should continue to be an agenda item. The Clerk advised of two workshop and training sessions for Councillors on Supporting Communities and Neighbourhoods in Planning to be held in February and arrangements were made for those wishing to attend.
- 12/11 **To receive PCSO Report**: The Clerk read out a communication from Sgt Sue Aufiero, Thames Valley Police. A new permanent replacement has been appointed for Police Community Support Officer Robert Hubbard Clark who has moved on to a new area, his name is Patrick Baker-Jones. Inspector Andy Ward is moving to a new area and a replacement will be appointed in due course.
- 12/12 To receive a letter from Thames Valley Police (TVP) advising of an internal review of how TVP is to deliver neighbourhood policing in West Berkshire: This was received and noted.
