# 21/0053 Schedule of Planning Applications

To consider the following planning applications:

# **20/02347/RESMAJ:** Land South of Tower Gardens, The Street, Mortimer Common, Reading, West Berkshire

Approval of Reserved matters for details of the appearance, landscaping, and scale of the approved residential development for Phase 2a comprising 16 houses including affordable housing and associated landscaping.

The Committee reviewed the drawings and plans and had no objections in principle. Overall, the details were as expected from the earlier outline application.

After general discussion on the proposals, and the situation on affordable housing and building regulations considering future climate change initiatives, the Committee agreed to raise concerns with West Berkshire Council on:

- The very small square meterage proposed for the affordable houses.
  Proposed by Cllr. Morsley and seconded by Cllr. Hill:
  AGREED unanimously.
- Although it understood these are not direct planning issues but dealt with by building regulations, the committee strongly urges that solutions to combat climate change such as solar panels, electric car charging points and better insulation are required on all homes yet to be built.

Proposed by Cllr. Hill and seconded by Cllr. Marsden:

AGREED with one vote against.

Cllr. Lewis raised the issue about facilitating the viewing of large-scale developments and obtaining paper copies on planning drawings from West Berkshire Council in future.
