

# Stratfield Mortimer Parish Council Community Grant Fund Policy

#### POLICY STATEMENT

Stratfield Mortimer Parish Council (SMPC/the Council) has the power to award grants under certain powers including s.137.

When able, the Council allocates funds from its General Reserves to award grants to support non-profit or charitable organisations which can demonstrate a clear need for financial support to achieve an objective which will benefit the Parish or its inhabitants by:

- Providing a service
- Enhancing the quality of life
- Improving the environment
- Promoting the Parish of Stratfield Mortimer in a positive way

Grants awarded will be at the Council's discretion and based on the merits of the application, eligibility criteria, and the funds available for grants in the applicable financial year.

This policy sets out:

The Council is under no obligation to award a grant just because an application has been made

# 1. ELIGIBILITY FOR FUNDING

- 1.1. Applicants must be either a charity, voluntary organisation or non-profit making organisation.
- 1.2. Organisations should be properly constituted and should have a bank account in its own name.
- 1.3. The purpose of the grant must be to support initiatives for the benefit of the Parish and/or its inhabitants that are not, as a matter of course, funded by the Council.
- 1.4. The purpose of the grants may be for capital or revenue costs. Applications for revenue costs must be for a new one-off application and for a specific reason i.e. post Covid restart. The provision for the future funding of the revenue costs must be clearly demonstrated.
- 1.5. The need for the grant must be current i.e. retrospective applications will not be funded where the expenditure has been made, the project has been carried out or the event has taken place.

1.6. An organisation must not have previously applied for a grant in the current financial year.

#### 2. APPLICATION PROCESS

- 2.1. Applicants will be required to complete the Community Grant Fund Application Form, available from www.stratfield-mortimer.gov.uk or by emailing the.clerk@stratfield-mortimer.gov.uk. All questions on the application form should be fully answered and supporting information provided.
- 2.2. The application for grant funding will be considered by the Council at its next appropriate scheduled Full Council meeting. A representative of the application may attend the meeting to answer any questions and support the application.
- 2.3. The Full Council shall make the decision on which grants to award. The applicant shall be advised of the decision as soon as possible following the meeting.
- 2.4. Payment of grants for successful applications shall be made within one calendar month.

# 3. DECISION CRITERIA

- 3.1. The power for the Council to legally make the grant.
- 3.2. The eligibility of the application.
- 3.3. The likely effectiveness of the purpose of the initiative and the benefit of the grant to the parish or its inhabitants. The benefit to the parish or inhabitants must be commensurate with the expenditure.
- 3.4. Whether the costs are appropriate and realistic.
- 3.5. What level of contributions have been sought or secured from other sources, including an organisations own fund-raising activities.
- 3.6. If sufficient funding could be raised from a more appropriate source.

# 4. CONDITIONS OF FUNDING

- 4.1. The administration of and accounting for any grant shall be the responsibility of the recipient. All grants must be properly accounted for, and evidence of expenditure should be supplied to the Council on request.
- 4.2. In all situations, a written account of how the grant has been used shall be submitted by the applicant to the Council within a year of the grant being paid.
- 4.3. Any grant must only be used for the purpose for which it was awarded unless the written approval of the Council has been obtained for a change in use of the grant monies.
- 4.4. In the event of the grant not being used, in part or in full, a full explanation shall be submitted to the Council within one year of the grant being paid. The Council reserves the right to ask for the grant to be repaid.
- 4.5. Organisations that receive a grant are asked to acknowledge the Council's contribution on all publicity where possible.
- 4.6. Ongoing commitments to award grants or subsidies in future years will not be made. A new application will be required each year.
- 4.7. Organisations are welcome to apply for grants in subsequent financial years, regardless of the outcome of previous applications.
- 4.8. The Council reserves the right to refuse any grant application which it considers to be inappropriate or against the objectives of the Council.

- 4.9. The Council may make the award of any grant or subsidy as it considers appropriate in the event of any unforeseen urgent event.
- 4.10. The Council may make the award of any grant subject to such additional conditions and requirements as it considers appropriate.

# 5. POLICY REVIEW

5.1. The policy will be reviewed as required.
