 Tower House Farm (previously referred to as MOR006: Land south of Tower Gardens) Planning Application

Cllr. Morsley advised that a resident had referred some technical queries to West Berkshire Council on the issue of storm water, drainage and a spoil tip at locations on the new phase of the development. The parish council office shared these queries with Mr. Tennant (co-opted Planning Committee member) and Mr. Wingfield (ex-councillor) for their information and comment as this Committee does not have technical knowledge on the issues raised. The Clerk will follow up with West Berkshire Council in two week' time if there has been no response.

## 22/0133 Items for information only

#### a. Decisions and Notices from West Berkshire Council

The following decisions were received:

# 22/01080/FUL: Manns Farm, Nightingale Lane, Mortimer, Reading, West Berkshire RG7 3PS

Conversion of existing farm building and replacement of existing to provide a 'Wellness Centre'.

**GRANTED** –14 October 2022

**SMPC Comments**: The parish council supports the proposed development under its NDP (Stratfield Mortimer Neighbourhood Plan policy 11.2.4 Use of Farm Buildings) on the assumption that the barn is not listed. The Committee had some concerns whether there were sufficient parking spaces to accommodate the potential full capacity referred to in the Highway Technical Note on page 3. The parish council also noted that the design access and planning statement referred to a consultation with "the parish council (Stratfield Mortimer)" at paragraph 3.1 but the council were not aware of this.

# 22/02016/CERTP: Wood View, Sweetzers Piece, Mortimer, Reading, West Berkshire

Part garage conversion into habitable room.

LAWFUL –13 October 2022

#### 22/02144/PASSHE: Bruncketts, The Street, Mortimer, Reading, RG7 3PE

Application to determine if prior approval is required for a proposed: Larger Home Extension - single storey rear extension with Ultraframe 380 replica glazed roof panels. Dimensions 3.50m from rear wall, 3.50m maximum height, 2.25m eaves height. **PRIOR APPROVAL NOT REQUIRED** –13 October 2022

# 22/01610/HOUSE: Park Cottage, The Street, Mortimer, Reading, West Berkshire RG7 3PE

Erection of a single storey rear extension.

GRANTED -21 October 2022

**SMPC Comments**: No objections but the Committee would ask that the case officer verifies the number of parking spaces as this was not shown in the proposal and number of bedrooms not indicated in the plans.

- Cllr Morsley raised the issue of meetings where there are only one or two simple applications (like this one) and the effort of setting up projector and all members attending. Hill, it was reported there has been no acknowledgement or response from the Planning team at West Berkshire Council to the parish council's enquiry regarding the new fencing erected at 2 Crockers which appears to contravene condition 3 on 22/00319/FULD decision letter of 6<sup>th</sup> April 2022.
