8.	Brief overview – what are you looking to provide? (max 100 words)	A grant to support the operational work of TiM Friends in the community of Mortimer. TiM Friends provides a befriending service for the lonely and isolated in our community. Our volunteers visit their clients weekly in the clients homes. Where possible we also will take clients out on trips and to organised social activities or events we arrange.
9.	Please describe in full your business case, including: • Set-up costs • Revenue costs	The cost of operating TiM Friends for 2023 will be £10,500 (£9,548 in 2022). This excludes the charities general overheads such as Audit 8 accounting, Insurance & other genral admin costs. It also excludes the charities other activity of operating a community Cafe. The costs for operating TiM Friends, for 2023 will be circa £8,500k for a paid co-ordinator, running community events (coffee & craft mornings, Silver lunches etc volunteer training and DBS checks circa £1,750 plus other expenses of circa £250. Funding for TiM as whole charity with a break out of the funding for specificially for TiM friends is provided on the continuation page. All the revenue for operating TiM friends comes from gifts and grants.
10.	Any supplementary evidence you feel is appropriate (max 500 words)	TiM Friends visits 46 clients in the RG7 area of West Berkshire of this over half our clients, 27 are in Mortimer. We have 33 volunteers who visit our clients and 1 of the volunteers are from Mortimer. With over 50% of TiM Friends activity being in Mortimer we would therefore see approximately 50% of the costs of running the activity being attributable.

The community benefit provided by TiM Friends is the reduction of loneliness and isolation in the community of Mortimer. With an aging population, increased levels of isolation and a greater pressure on social services and statutory care in general, being able to provide a service that is based on geniuine friendships and care at a truly local community level ensures that those who are elderly and on their own feel valued and cared for by thier own community.
