Minutes of the Finance and General Purposes Committee held at Mortimer Methodist Church Hall on Thursday the 6th of June 2023 at 7.30pm.

23/001 Public Questions (for agenda items only)

23/002 To receive any apologies for absence

Apologies were received from Cllr. S. Hill. Cllr. Butler did not attend, and no apologies were received.

23/003 To receive any declarations of interest

23/004 Minutes of Last Meeting

23/005 Clerk's Report

To receive a report from the Parish Clerk outlining actions taken following the meeting held on the 4th of May 2023 and other updates.

The Clerk reported The Public Sector Deposit Fund rate of return on investment as at the 31st of May 2023 was 4.4486%. The rate as at the 31st of March 2023 was 4.1223%. The Clerk confirmed that no response had been received from West Berkshire Council regarding the invoice for rent arrears which is believed to have been raised in error.

23/006 Items to be taken into private session

23/007 Items for Consideration and Resolution

1. Internal Audit Report

To receive the Internal Audit Report for presentation to Full Council on Thursday the 8th of June 2023.

The internal auditors report was received.

- 2. Annual Governance and Accountability Return (AGAR)
 - a. To receive and consider AGAR Section 1 Annual Governance Statement 2022/23 for presentation to full Council.
 - b. To receive and consider AGAR Section 2 Accounting Statements 2022/23 for recommendation for approval by full Council on Thursday the 8th of June 2023.

AGAR Section 1 and 2 were both received and reviewed. It was noted that the External Auditor report 2021/22 report concluded "Section 2 was not dated by the Responsible Financial Officer" and that the Council needs to make sure the forms are correctly completed in future years. The error occurred because the form did not correctly print out. The form for 2022/23 has printed correctly and includes all boxes which need completing.

3. Annual Governance and Accountability Return – additional documents

To receive the following documents which will be submitted to the External Auditor:

The documents were received and reviewed.

4. Community Infrastructure Levy

To receive an update on CIL funds and expenditure.

Cllr. Morsley summarised the CIL funds currently held and the likely near-zero balance if all allocated CIL funds are used. It was noted that a delay in the building of MOR006 Phase 2b (and possibly Phase 3) would affect the timing of future CIL payments to the Council. Once those are received however, the Council is unlikely to receive any significant CIL funds for the foreseeable future.

Consideration was given to all the earmarked reserves, and it was agreed that committees and working parties should review current levels of the reserves to understand if they are an accurate reflection of what is needed. This will be considered at a future meeting with a view to implementing a regular review period.

5. Fairground Closed Circuit Television (CCTV)

To consider and review the draft CCTV Surveillance System Policy and Request for Access to Data, and the Data Privacy Impact Assessment (DPIA) for approval by full Council on Thursday the 8th of June 2023.

The documents were received.

6. Personnel Sub-Committee

To appoint the members of the Personnel Sub Committee.

Cllr. Morsley proposed that Cllrs. Geary and Marsden be appointed to the Personnel Sub Committee with Cllr. Dennett being co-opted for an initial period. Seconded by Cllr. Bridgman.

Resolved unanimously.

7. Bank Reconciliation and Quarterly Internal Financial Control

To consider the appointment of a member or members of the Committee or Council to:

- a. Undertake the verification of the bank reconciliations for all accounts as per Financial Regulation 2.2.
- b. Complete the Quarterly Internal Financial Control.

Cllr. Morsley proposed that Cllrs. Noonan and Bridgman be appointed to undertake the bank reconciliations and the quarterly Internal Financial Control respectively. Seconded by Cllr. Geary.
