#### 23/013 To receive any apologies for absence

## 23/016 Update from Previous Committee Meeting(s)

To review the Action Tracker and receive an update outlining actions taken from the meeting held on the 29th of June 2023.

The Action Tracker was reviewed and updated and the following noted:

- Skunk cabbage: the Clerk will inform West Berkshire Council (WBC) of the location of skunk cabbage that has been spotted in the parish.
- Gigaclear: WBC officers and Dist. Cllr Poole are following up on the reinstatement works on Highways land. A letter will be sent to Gigaclear, copied to WBC, regarding the reinstatement works on unadopted roads.
- Speed Indicator Device (SID) & Automatic Speed Watch Camera (ASWC):
  - o Cllr. Marsden will write text seeking further volunteers.
  - Cllrs. Bridgman, Marsden, and Wells are attending WBC's CSW Seminar –
    Cllr. Dennett to provide data and photos.
  - o Cllr. Dennet has applied for four further ASWC locations.
- Management of commons: Cllr. Shaw has written a review which he will share with Committee members, and which will be considered at the next meeting. The Clerk will write to the landowner of the woods opposite The Fairground on Hammonds Heath regarding the management of the woods.
- Swallowfield Community SpeedWatch: Cllr. Marsden reported Swallowfield have suspended their SpeedWatch campaign due to a lack of letters being issued and the content of letters not strong enough. The Clerk will write to TVP and request a copy of the letter and confirmation of the number and types of letters sent depending on repeat offences.
- War Memorial: Cllr. Bridgman confirmed the cleaning of War Memorial is taking place over the next two weekends.

The wording of a card for advising residents of hedge issues was reviewed. Cllr. Marsden will rewrite the text and circulate for comment.

It was agreed for:

- Members of the Committee to report the location of overgrown hedges identified via a Hedges WhatsApp group.
- The Office to continue to maintain a record of overgrown hedges and action taken. To be kept on SharePoint.
- Cards and the "Don't let your hedge be a hazard" leaflets to be posted through letterboxes and letters sent to landowners, as appropriate.
