Part I

24/013 Chairman

To elect a Chairman for the Roads, Footpaths and Commons Committee.

Cllr Kilshaw proposed Cllr Bridgman to be the Chairman of the Committee.

Seconded by Cllr Morsley.

Resolved with one abstention.

To review the Action Tracker and receive an update outlining actions taken from the previous meetings.

The Action Tracker (attached) was reviewed and outstanding items discussed and further actions identified as indicated.

24/021 Items for Consideration and Resolution

1. Policies

To consider any Policies within the ambit of the Committee requiring consideration, amendment or proposal to full Council.

2. Budget 2025/26

To consider the Roads, Footpaths and Commons budget for 2025/26 and agree the amounts required for recommendation to Finance and General Purposes.

Minuted at Part II.

3. Tree Surveys

To consider the need for tree surveys for Five Oaken Common and Brewery Common and agree any further actions and associated budgets.

The Clerk summarised the current situation with the tree surveys. It was agreed to:

- a. Consider the need for a tree survey for Five Oaken Common once the cycleway and footpath is in place.
- b. Establish with West Berkshire Council (WBC) their responsibilities for Brewery Common under the "Brewery Common Scheme" and then review and propose any necessary actions.

4. SID and ASWC deployments

To receive an update on the deployments of SID and ASWC and to consider future activities.

Cllr Dennett and one of the members of public present gave an update on the SID and ASWC deployments and the data captured. The need for additional volunteers was discussed. It was agreed to:

- a. Write an advert for social media seeking additional volunteers.
- b. Seek councillor volunteers.
- c. Review the current SID & ASWC deployment sites and apply for others where needed.
- d. Look at other alternative ASWC systems.
- e. Establish via WBC the deployment rules around SID/Sentinel system.

5. Hedges

To agree a plan for monitoring and managing overgrown hedges throughout the parish.

Cllr Morsley gave an update and reported that many hedges remain overgrown with WBC failing to use their powers to address the issues even when reported.

It was agreed to:

- a. Continue to post cards and hedge leaflets through letterboxes of properties with overgrown hedges and if no action taken by the resident to report the hedge issue via the WBC website.
- b. To liaise with WBC regarding the management of overgrown hedges and establish actions SMPC can take to assist with the process.

6. Public Rights of Way: STRA/43A/1 and STRA/43B/1

To consider the issues around the routes of the footpaths and agree any actions to be taken.

Cllr Bridgman gave a history of the footpaths and confirmed that currently sections of the footpath are on either side of the hedge, partly in Hampshire and partly in Berkshire. Ideally a contiguous route should be established on easterly side of the hedge. It was agreed to formally write to Englefield Estate as landowners, referring them to previous correspondence with the farmer and asking them to agree to join the paths together as one contiguous footpath.

7. St Mary's School and The Street Parking

To receive an update and:

- a. **Consider the responses received regarding the repainting of the white lines.**

It was confirmed that out of the seven properties contacted regarding the white lines only three had responded and of those, only two were prepared to pay towards the cost of having the white lines repainted. In addition, previously at a meeting with WBC and the school, the repainting of the faded yellow lines and the painting of yellow lines from Pitfield Lane travelling up the hill had been discussed.

Cllr Bridgman proposed liaising with WBC regarding the simultaneous painting of both the yellow and white lines with a view to SMPC paying for the repainting of the white lines if an appropriate price can be agreed.

Seconded by Cllr Morsley.

Resolved unanimously.

b. Agree any further actions regarding the issues and potential solutions around parking on The Street in the vicinity of the school.

Cllr Bridgman gave an update on recent correspondence from the school regarding the parking issues and possible solutions, to which one member of the public contributed. Further to the meeting held earlier on in the year with the school and WBC, it was agreed to ask WBC for an update regarding:

- a. The repair/replacement of the flashing sign located to the eastern side of the school.
- b. The road sign for traffic travelling in a westerly direction showing Mortimer Lane as a T junction when it is really a staggard crossroads with Church Farm Barns.
- c. Adding road restrictions (i) between Church Lane and Church Farm Barns (ie opposite the Mortimer Lane junction), and (ii) from Pitfield Lane up The Street towards the crossing.
