The Council

Introduction

53 The Council is the tier of local government responsible for the Parish.

64 ~~The~~Subject to any vacancies, the Council consists of fifteen Councillors, elected every four years.

75 In the event of a casual vacancy the Clerk will follow a statutory process that may result in either a by-election or in a co-option process to fill the vacancy.

86 The Parish is within the District of West Berkshire, and thus within the local authority area of WBC. WBC is a first-tier, unitary, authority responsible for the full range of local government services, such as education, transport, planning, social care, waste, trading standards, council tax collection, housing, and licensing.

Council Chairman and Vice-Chairman

97 The Council has a Chairman and Vice-Chairman and:

9.17.1 ~~subject to these Standing Orders, anything authorised or required to be done by, to or before the Council Chairman may in their absence be done by, to or before the Council Vice-Chairman;~~

9.27.2 ~~unless they have resigned or become disqualified, the Council Chairman and~~ Council Vice-Chairman shall continue in office until the election of the Council Chairman at the next Annual Meeting.

Creation and General

~~108~~ TheUnless the Council Resolves otherwise Parent Bodies may appoint Sub-Bodies as necessary, and determine their Terms of Reference, and: powers to act.

Membership

~~15~~13 Only Councillors may be Members of a Body which regulates and controls the finances of the Council.

~~16~~14 Unless the Council determines otherwise, Councillors and non-Councillors may be Members of a Body other than one which regulates and controls the finances of the Council.

~~17~~15 Unless the Council determines otherwise, all Members of an Advisory Committee and/or a Sub-Committee of an Advisory Committee may be non-Councillors.

~~18~~16 The Council Chairman and Council Vice-Chairman shall be ex officio ~~Voting~~Members of every Committee.

~~19~~ The Council may dissolve a Body.

~~20~~ A Committee may dissolve a Body it has created.

17 The Terms of Reference will determine whether a non-Councillor appointed to a Committee or Sub-Committee is a Voting Member of that Body, but if the Body is one established for the purposes of s13(4)(g) of the 1989 Act to perform any of the following functions they will be such a Voting Member in respect of those functions:

17.1 the management of land owned or occupied by the Council;

17.2 where the Council is a harbour authority as defined in s57(1) of the 1964 Act, their functions as such;

17.3 any function under s144 of the 1972 Act relating to the promotion of tourism;

17.4 any function under s145 of the 1972 Act relating to the management of a festival.

Powers to Act

18 The scope and (where relevant) powers to act of each Body are set out in the Scheme of Delegation.

Meetings - General

Meetings Overview and Quorum

~~21~~19 In addition to the Annual Meeting, at least three other Ordinary Council Meetings shall be held in each Municipal Year on such dates and times as the shall Council decide.

20 Council and Committee Meetings shall not take place at premises which at the time of the Meeting-:

~~21-1~~20.1 are used for the supply of alcohol, unless no other premises are available free of charge or at a reasonable cost-; or

20.2 are used as dwelling-houses; or

20.3 would interfere with the hours in which the premises are used for educational purposes, the administration of justice, or by the police;

(Sub-Committee and Steering Group Meetings are not subject to the provisions in Paragraph 20).

~~22~~21 Meetings shall be held upon at least three Clear Days' notice.

~~23~~22 No business may be transacted at a Meeting unless the number of Voting Members present is at least:

~~23-1~~22.1 three and also one-third of the Voting Membership for a Council or Committee Meeting; or

~~23-2~~22.2 the quorum set out in the relevant Terms of Reference for a Meeting of Body other than a Sub-Committee, or Working Group three if no quorum is so set out.

~~24~~23 If a Meeting is or becomes inquorate no (further) business shall be transacted and the Meeting shall be closed. The business on the Agenda shall be adjourned to another Meeting.

~~25~~24 A Meeting shall not exceed a period of two hours unless otherwise agreed in accordance with Standing Order Paragraph 52.18.

~~26~~25 An invitation to attend a Council Meeting shall be sent, together with a copy of the Agenda, to each WBC Ward Councillor.

Annual Meeting

~~27~~26 In an Election Year, the Annual Meeting shall be held on or within 14 days following the day on which the Councillors elected take office.

~~28~~27 In year other than an Election Year, the Annual Meeting shall be held on such day in May as the Council decides.

~~29~~28 If no other time is fixed, the Annual Meeting shall commence at 18:00.

~~30~~29 The first business conducted at the Annual Meeting shall be the election of the Council Chairman and Council Vice-Chairman.

~~31~~30 In an Election Year, if the current Council Chairman has not been re-elected as a Councillor, they shall not have an original vote in respect of the election of the new Council Chairman but shall give a casting vote in the case of an equality of votes.

~~32~~31 Following the election of the Council Chairman and Council Vice-Chairman the business of the Annual Meeting shall include:

Extraordinary Council Meetings

~~40~~41 With the agreement, and at the direction, of the Meeting Chairman, members of the public may make representations, ask and answer questions, and give evidence at a Meeting which they are entitled to attend in respect of the business on the Summons or, with the permission of the Meeting Chairman, any other matter, and:

~~53~~54 No Motion may be moved at a Meeting unless the proposer has given written notice of its wording to the Clerk at least fourteen Clear Days before the Meeting and it has been included on the Summons.

~~54~~55 The Clerk may, before including a Motion received in accordance with these Standing Orders on the Summons, correct obvious grammatical or typographical errors in the wording of the Motion.

~~55~~56 If the Clerk considers the wording of a Motion received in accordance with these Standing Orders is not clear in meaning, the Clerk may seek to agree a re-wording with the proposer but may require the proposer to table an amended Motion, such that its meaning is clear, in writing at least ten Clear Days before the Meeting.

~~56~~57 If the wording or subject of a proposed Motion is considered improper, the Clerk shall consult with the Council Chairman or Body Chairman as relevant to consider whether the Motion shall be included in the Summons or rejected.

~~57~~58 Subject to ~~Standing Order~~Paragraph 57, the decision of the Clerk as to whether or not to include the Motion on the Summons shall be final.

~~58~~59 Motions received shall be recorded and numbered in the order that they are received.

~~59~~60 Motions rejected shall be recorded with an explanation by the Clerk of the reason for rejection.

Motions on Notice – Procedure

~~60~~61 Motions on the Summons shall be considered in the order that they appear unless the order is changed at the discretion of the Meeting Chairman.

~~61~~62 A Motion (including an amendment) shall not be progressed unless it has been moved and seconded.

~~62~~63 A Motion on the Summons that is not moved by its proposer may be treated by the Meeting Chairman as withdrawn.

~~63~~64 If a Motion (including an amendment) has been seconded, it may be withdrawn by the proposer only with the consent of the seconder and the Voting Members.

~~64~~65 An amendment is a proposal to remove or add words to a Motion – it shall not negate the Motion.

~~65~~66 If an amendment to the original Motion is carried, the original Motion (as amended) becomes the substantive Motion upon which further amendment(s) may be moved.

~~66~~67 An amendment shall not be considered unless early verbal notice of it is given at the Meeting and, if requested by the Meeting Chairman, is expressed in writing.

~~67~~68 A Member may move an amendment to their own Motion if agreed by the Meeting, provided that, if the Motion has been seconded, the seconder agrees.

~~68~~69 If there is more than one amendment to an original or substantive Motion, the amendments shall be moved in the order directed by the Meeting Chairman.

~~69~~70 Subject to ~~Standing Order~~Paragraph 71, only one amendment shall be moved and debated at a time, the order of which shall be directed by the Meeting Chairman.

~~70~~71 One or more amendments may be discussed together if the Meeting Chairman considers this expedient but each amendment shall be voted upon separately.

~~71~~72 A Member may not move more than one amendment to an original or substantive Motion.

~~72~~73 The mover of an amendment has no right of reply at the end of debate on it.

~~73~~74 Where a series of amendments to an original Motion are carried, the mover of the original Motion shall have a right of reply either at the end of debate on the first amendment or at the very end of debate on the final substantive Motion immediately before it is put to the vote.

~~74~~75 Unless permitted by the Meeting Chairman, a Member may only speak once in the debate on a Motion except:

~~74.1~~75.1 to speak on an amendment moved by another Member;

~~74.2~~75.2 to move or speak on another amendment if the Motion has been amended since they last spoke;

~~74.3~~75.3 to make a point of order;

~~75~~76 During the debate on a Motion, a Member may interrupt only on a point of order or a personal explanation and the Member who was interrupted shall stop speaking. A Member raising a point of order shall identify the Standing Order which they consider has been breached or specify the other irregularity in the proceedings of the Meeting they are alleging.

~~76~~77 A point of order shall be decided by the Meeting Chairman and their decision shall be final.

~~77~~78 When a Motion is under debate, no other Motion shall be moved except:

~~79~~80 Excluding points of order or personal explanations moved in accordance with ~~Standing Order Paragraph~~ 76, the contributions or speeches by a Member shall relate only to the Motion under discussion and shall not exceed five minutes without the consent of the Meeting Chairman.

Voting

~~80~~81 All questions at a Meeting shall be decided by a majority of the Voting Members present and voting.
