24/157 Minutes of last meeting

24/158 Chairman's remarks

- Cllr Richardson spoke on behalf of the Planning Committee in saying that the
 passing of Cllr Wells was a very sad moment for the council and that Cllr Wells will
 be missed dearly.
- Cllr Richardson had a report from a member of the public regarding 24/02732/CERTP - 15 King Street where works had already started without the CERTP being granted. Cllr Bridgman reported that if it does not fall under permitted development the applicant will need to submit a retrospective application. The Planning Committee does not submit comments for CERTP planning applications.
- Cllr Richardson reported that the downpipe/drainage issue at 35 Stephens Close has been passed to the Enforcement team at West Berkshire Council.
- The Eastern Area Planning Committee Meeting takes place on 5 March, but nothing on the agenda for us to attend.
- Cllr Richardson reported that the Planning Application fees will go up on 1 April and that more information is available on the West Berkshire wwebsite.

a Tower House Farm

GB reported that there is nothing new to report. We are still waiting on the planning application for the Reserved land.

b Mortimer to Burghfield Footpath/Cycleway

Cllr Morsley reported feedback from Ridge and Partners LLP. The drawing updates have been completed and will be submitted to WBC by the end of the week. This includes updates for the new bridge crossing location. The additional tree surveys have been completed. Aspect Ecology are to assess the impact of the current route and determine which trees need to be removed. The Bridge design will follow now the bridge crossing position has been resolved.

25/00296/TPW: 3 St Marys Road Mortimer Common Reading RG7 3UE

T1 - Ash: Reduce canopy by 1-2 metres to suitable growth points. No cuts to exceed 50mm manage tree in its position similar to last prune. As per photo provided. T2-Sycamore: Reduce crown by 1-2 metres to suitable growth points whilst retaining nice tree shape and balance. No wounds to exceed 50mm server lvy. As per photo provided
