#### a Tower House Farm

Cllr Bridgman reported that we are still waiting for the planning application for the reserved land. We are also still waiting to hear back from West Berkshire Council re the maintenance of the public open space.

#### b Mortimer to Burghfield Footpath/Cycleway

Cllr Richardson reported that a Steering Group (SG) meeting was held prior to the Planning Committee meeting to discuss where we are with the whole project. There are concerns about the rising costs. Cllr Kilshaw will lead the SG from 15 May and Cllr Morsley will step down as lead. The SG is going to take a new angled look at the project with the view to take control back and to try to start things moving and approach smaller local contractors.
