### **Minutes of the Meeting of the Planning & Highways Committee held on Thursday 9 October 2025 at Mortimer Methodist Church Hall, West End Road, Mortimer, RG7 3TB**

The meeting commenced at 18:45.

#### **Part I**

##### **25/090 Apologies**

No apologies were received.

##### **25/091 To receive any declarations of interest**

Some members of the committee declared they knew the applicant personally for the planning application under agenda item 25/100. There were no pecuniary interests declared.

##### **25/092 Public Questions**

Three of the members of the public were from the Neighbourhood Steering Group (NPSG) were invited and were there for agenda item 25/097b relating to Mortimer West End Farm. The fourth member was the applicant for the Planning application listed under agenda item 25/100. (see below). No questions were raised at this point.

**25/093 Minutes of last meeting**

The Minutes of the Planning and Highways Committee meeting held on Thursday 18 September 2025 were received with no amendments and resolved unanimously for signature by the Chairman as a true record of the meeting.

**25/094 Chairman's remarks**

Cllr Richardson noted that during the Mortimer West End Farm process it is important that the Planning and Highways Committee communicates effectively.

**25/095 Items to be taken into private session**

Cllr Richardson proposed item 25/099 Budget 2026/2027 to be taken into private session. Resolved unanimously.

**25/096 Policies**

None to discuss.

**25/097 Current Projects**

**a Tower House Farm**

Cllr Bridgman reported that there were 3 issues: -

- Firstly, the council is still awaiting the application for the reserved land.
- Secondly, some of the residents in the Avenue, who had written to West Berkshire Council (WBC) in relation to the retaining wall, were unhappy with the responses received from Planning and from Building Control. Although they had received an initial response they had heard no more.
- Thirdly, TA Fisher had sent an email saying that the paths around the ponds had been completed and connected to the footpath that runs alongside the Avenue. So, it is ready to be connected into what will be the permitted path up the side of the field offered by Englefield.

The next task for the Assistant to the Clerk will be to write to Englefield to make them aware the footpaths are in place at Tower Gardens, and that we would now like to discuss what needs to be done to make the footpath up the side of the field and the connection out onto Drury Lane and whether there will be a gate.

**b Update on Mortimer West End Farm**

Cllr Richardson reported that there had been a lot of correspondence since the last Planning and Highways meeting. Letters were sent to Basingstoke and Deane and WBC declaring that SMPC objects at this stage. The next stage of the process is the Regulation 18 consultation.

Cllr Bridgman reported that Basingstoke & Deane Borough Council and WBC had responded to the letters. We are less satisfied with the response from WBC.

Cllr Bridgman noted that he and Cllr Kilshaw, Bob Coe from the NPSG, the Action Group from Turks Lane (etc), and various others, had attended the Mortimer West End Parish Council meeting on 2 October where they had heard from the Leader of Basingstoke and Deane, the Portfolio holder and one of the local members. The

Basingstoke and Deane councillors were apologetic but said that their hands are tied as they have been set a housing target and are under a lot of pressure.

An in-depth discussion followed including the three members of the NPSG present – the conclusion was that we need to decide what we do before the Regulation 18 consultation starts and act as one voice.

The main points raised: -

- The proposed 350 homes site at Mortimer West End Farm will be mentioned at the NPSG public consultations starting this weekend.
- Jo Wines (Chairman of the NPSG) raised the point that currently we do not have a cross-boundary Neighbourhood Plan Area with Mortimer West End. Do we have time to do this as new SMPC NP Plan needs to be in place July 2026? She also noted we need some legal advice regarding a large development right on our border when we have a NP.
- Tenant Barber from the NPSG mentioned that petitions in general do not carry much weight, so we need to focus on the legalities and the rules of the planning system. He suggested that SMPC take on a legal planning expert.
- Cllr Bridgman proposed that SMPC respond to WBC as they did not mention the approach they will be taking and as they have the duty to cooperate - SMPC would like to know what discussions have or will take place with Basingstoke and Deane Borough Council. Cllr M Dennett seconded, and this was resolved unanimously (Cllrs Richardson, Bridgman and the Assistant to the Clerk to construct).
- There was a discussion whether a separate Working Party should be formed – whether under the Planning and Highways Committee or the NPSG – or whether to have as an independent group with outside members.
- Cllr Kilshaw proposed a public meeting is held on 25 October (if a suitable venue can be found) and based on the outcome of that we decide our next steps. Cllr Bridgman seconded - resolved unanimously
- Cllr Bridgman proposed that for the NPSG Budget we change the scope of the EMR so we can pay for legal, technical and planning advice with regard to this issue. Cllr A Richardson seconded - resolved unanimously.

#### **25/01572/COND: Four Houses Corner Reading Road Ufton Nervet Reading**

Application for approval of details reserved by Condition 4 - Emergency Plan, of approved 23/01552/REG3 (It is proposed to replace the existing permanent 18 pitch Gypsy caravan site with a new 17 permanent pitch Gypsy caravan site. Each pitch is to consist of a hard standing area large enough for two twin axle caravans, car parking for two vehicles and a 30 sq m amenity building consisting of a kitchen/dayroom, bathroom, separate WC and utility area. In addition to the amenity buildings a recycle storage facility, children play area are to be located within the site).

**SMPC Comments** - Stratfield Mortimer Parish Council considered the plans for this application at its Planning & Highways Committee meeting on 17 July 2025 under agenda item 25/047 and is concerned that the ground plan that has been provided for this application is the same plan as was submitted with the refused application 25/00992/NONMAT, and not the one for which there is permission under 23/02038. The Council objects to any variation of the Approved Plans that would result in a reduction of the garden areas associated with three of the dwellings (as had been sought by 25/00992 but refused).
