The meeting commenced at 18:45.

Part I

25/107 Apologies

Apologies were received from Cllr J Todd.

25/108 To receive any declarations of interest

None were received.

25/109 Public Questions

Two of the members of the public were Jo Wines and Doug Overett from the Neighbourhood Steering Group (NPSG) and were there for agenda item 25/114.b relating to the creation of a new Basingstoke and Deane Local Plan Steering Group. The other three members of the public were residents who had indicated an interest in joining the same group. No questions were asked at this stage.

25/110 Minutes of last meeting

The Minutes of the Planning and Highways Committee meeting held on Thursday 9 October 2025 were received with no amendments and resolved unanimously for signature by the Chairman as a true record of the meeting.

25/111 Chairman's remarks

Cllr Richardson noted: -

- Doug Overett had indicated a desire to be co-opted onto this committee, and this
 would be dealt with at the next Full Council meeting on 13 November. (Cllr Morsley
 noted that we will need to setup a separate SharePoint channel for the Planning
 and Highways Committee in order that co-opted non councillors can access the
 meeting papers.)
- The Parish Meeting held on 25 October had gone well with a large attendance of around 250 people.
- There were no planning applications to discuss.

The amended SMPC Scheme of Delegation was discussed under agenda item 25/114.b.

25/114 Current Projects

a Tower House Farm

Doug Overett from the NPSG reported that the developer TA Fisher were about to submit a planning application for the reserved land.

b Outcome of Parish Meeting held on 25 October regarding the proposed development of Mortimer West End Farm and to resolve whether to create a working party.

Cllr Bridgman reported that there was a proposal to create a new Steering Group for the proposed Basingstoke and Deane BC housing site at West End Farm (rather than a Working Party, since this project could take some time).

The following actions were taken:

- An amended Scheme of Delegation, incorporating some changes made by the Clerk in accordance with her powers to reflect changing circumstances, and a new Appendix to create the new Steering Group, was reviewed and minor amendments agreed.
 - Cllr Bridgman proposed that the new Steering Group Appendix be approved. Seconded by Cllr Richardson. **Resolved** unanimously.
- The following members were proposed for the new Steering Group: Cllrs Geary, Kilshaw, Morsley, Strong and Todd, plus co-opted members from the NPSG: Ms J Wines and Mr D Overett, plus other interested individuals: Mrs L Clark, Mr G Parry, Mr J Weedon and Mr S Wightman.
- Cllr Kilshaw proposed the creation of the Basingstoke and Deane Local Plan Steering Group with that membership. Seconded by Cllr Bridgman. Resolved unanimously.

- Cllrs Geary and Kilshaw agreed to co-chair the Steering Group. Cllr Bridgman proposed to change the Terms of Reference allow for co-chairing. Resolved unanimously.
- The date of the first SG meeting was agreed for 3 November.

25/115 Steering Group Reports

The committee noted that the minutes from the Neighbourhood Plan Steering Group (NPSG) meetings of the 21 October had been received.

25/116 Items for consideration

1 To note the correspondence received from West Berkshire Council in relation to the Nuisance and Obstruction (N&O) process relating to overhanging vegetation on the public highway and agree actions to be taken.

Cllr Morsley reported that no real changes had been made to the process as far as SMPC was concerned. The council already writes to landowners if there are issues with overhanging vegetation. Cllr Morsley and Cllr Richardson agreed to prepare a response to West Berkshire Council.
